

4. To Adopt a new Constitution:

That, the existing constitution of the Company be revoked, and the Company adopt a new Constitution in the form tabled at the meeting and signed by the Executive Chairman for the purposes of identification. For further details, see Explanatory Note 3.

Resolutions 1,2 and 3 above are to be considered as ordinary resolutions and, to be passed, require the approval of more than 50% of the votes of those shareholders entitled to vote and voting on the resolution, pursuant to section 105(2) of the Companies Act 1993. Resolution 4 is to be considered as a special resolution and, to be passed, requires the approval of 75% or more of the votes of those shareholders entitled to vote and voting on the resolution, pursuant to section 2(1) of the Companies Act 1993.
